5. Bids must be submitted through e-GP system <https://www.bolpatra.gov.np/egp> on or before 12:00 Hrs on 6 November, 2018 (20 Kartik, 2075)

The bids shall be opened in the presence of bidder's representative who choose to attend at 14:00 Hrs, 6 November, 2018 (20 Kartik, 2075) at the office of District Co-Ordination Committee, Taplejung. Bids must valid for a period of 90 days after bid opening and must be accompanied by a bid security of scanned copy of the bid security in PDF format, amounting to a minimum of NRs. 3,50,00.00 which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
8. Matters not covered by this notice shall be in accordance with Public Procurement Act-2063, Public Procurement Regulations-2064 and their amendments.
9. The employer reserves the right to accept or reject wholly or partly any or all the bids without assigning any reason.
